NOTICE OF RESCISSION

Re: Meeting between UN Swissindo, OJK and Investment Alert Task Force – 23rd August, 2017

Date: 26th August, 2017

LET it be known, on behalf of UN Swissindo’s King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S”2”.IR. Soegihartotononegoro H.W.ST.M1 (M1), this day, the 26th August, 2017, that OJK and Investment Alert Task Force letter dated 23rd of August, 2017 is **rescinded, null and void ab initio.**

Let the Indonesian people know, and also the people of the world, who are watching and following UN SWISSINDO progress TO FREE HUMANITY through Payments 1-11, the facts and reasons for the OJK and Investment Alert Task Force letter HOLDS NO STANDING.

A King’s primary duty is to protect the people of whom he serves. UN Swissindo’s King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S”2”.IR. Soegihartotononegoro H.W.ST.M1 (M1) has acted under duress, in order to uphold his primary duty of protecting the people and avoid threats of arrest. The very fact that he, his UN SWISSINDO Officers and delegates alike, were threatened with arrest, unless he signed the OJK and Investment Alert Task Force Letter-previously prepared document means, in law, that it was signed under duress, has no legal or lawful standing in any court and in any land and is **rescinded, null and void ab initio.**

Let it be known for clarity the key points of fact so the people can understand:

1. UN Swissindo’s King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S”2”.IR. Soegihartotononegoro H.W.ST.M1 (M1) was invited by OJK on the 23rd of August, 2017 to “Explore and clarify the Legality of UN SWISSINDO”. This point is on record and he, his legal advisor and other UN SWISSINDO officers accepted and attended this meeting. OJK party also consists of members of Bareskrim Polri (RI Police) and Bank Indonesia.
2. OJK party did not act in honor. They then proceeded to:
 - a. refuse entry of most of M1’s advisors, also HNP & Partners, the advocates were invited to represent the people, the beneficiaries of M1 Vouchers.
 - b. interjected with dishonorable behavior and disallowed him to speak.
 - c. ignored the agreed agenda, to explore the legality and clarification of UN SWISSINDO.
 - d. refused to accept or view documentation and certificates of legality that have been previously provided to all authorities, including The Supreme Court of Indonesia, who have signed a Joint Decree Acceptable Certification with UN Swissindo, Non Litigation / Trial SPRIN NO. UN-81704/009 M1, which is in accordance with the contents of the Grand Acclamation that was publicly announced by M1 on October 16, 2016 at Taman Pandang, in front of the State Palace of Jakarta.





- e. refused to acknowledge:
- i. his standing as UN Swissindo's King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S''2''IR. Soegihartotonegoro H.W.ST.M1 (M1).
 - ii. UN Swissindo being the parent organization and therefore being higher than highest institution for Nation and Country. This fact alone in law means that OJK has no jurisdiction over UN Swissindo's King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S''2''IR. Soegihartotonegoro H.W.ST.M1 (M1), or UN SWISSINDO.
 - iii. That UN Swissindo or Swissindo World Trust International Orbit is a Non-Profit Humanitarian Organization and not an investment entity. That it has its own assets, independent and outside of any jurisdiction that OJK could legally claim.
 - iv. UN Swissindo's King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S''2''IR. Soegihartotonegoro H.W.ST.M1 (M1), offer, as grantor, of his gift to all people – including OJK party – of Payments 1-11.
- f. The facts above were conducted in an aggressive and threatening manner, including making threatening statements that UN Swissindo's King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S''2''IR. Soegihartotonegoro H.W.ST.M1 (M1), his UN SWISSINDO officers and other delegates will be arrested, unless he signs a pre-scribed document that had not been disclosed in the invitation/Agenda.

Therefore, let it be known to the beloved people of Indonesia and the world that UN Swissindo's King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S''2''IR. Soegihartotonegoro H.W.ST.M1 (M1) is taking his primary duty to protect the people, with knowledge that:

1. OJK has no jurisdiction over M1 or UN Swissindo
2. The meeting was conducted dis-honorably, with intent to coerce in a threatening manner and action an undisclosed and pre-scribed document of no standing.
3. That the contents of the pre-scribed document presented to UN Swissindo's King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S''2''IR. Soegihartotonegoro H.W.ST.M1 (M1), were:
 - a. Incorrect and false in detail
 - b. That there was no contractual consideration. The pre-scribed document was a one sided offer with no consideration and no mutual consideration.
 - c. That the pre-scribed document was presented as an ultimatum by OJK party and that the terms of the document were based on threats of action of harm, if he did not sign as his capacity as UN SWISSINDO Top President. This creates a state of duress, and no contract, no agreement of any other document that is "void ab initio", in any court, in any land.
 - d. That the name of the person on the pre-scribed document presented to UN Swissindo was incorrect. This important fact in contract law means that the correct Authorized Signatures and/or Authorized Persons were absent. Therefore to sign as Sugihartono, as pre-scribed by OJK party means that no Authorized Signature and/or Authorized Person has signed any agreement. This can be clearly witnessed on the document compared to his signature as UN Swissindo's King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S''2''IR. Soegihartotonegoro H.W.ST.M1 (M1) on official UN Swissindo documents such as the DBLC and M1 Voucher.

Therefore, by the facts stated above UN Swissindo's King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S''2''IR. Soegihartotononegoro H.W.ST.M1 (M1) knew that the meeting and pre-scribed documents presented by OJK party had:

1. Absence of Jurisdiction
2. Absence of internationally accepted contractual protocol being followed
3. A state of duress had been created, with threats of harm to himself and his beloved UN SWISSINDO officers and delegates
4. Incorrect and false document that has no standing
5. Incorrect person as Authorized Signatory

Therefore, UN Swissindo's King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S''2''IR. Soegihartotononegoro H.W.ST.M1 (M1), in order to protect himself and his beloved UN SWISSINDO Officers and delegates from harm, with knowledge of the above signed as Sugihartono, an unauthorized signatory for UN SWISSINDO, under duress and with knowledge that this document is null and void ab initio and can and has been rescinded.
