INDONESIAN IN ECONOMIC EMERGENCY ... UN SWISSINDO HAS ONLY SOLUTION!

CIREBON, JAVA, Indonesia, November 12, 2017 – Indonesia is currently in a state of Economic Emergency, due in part to its leadership deliberately engaging in treasonous acts, including the selling of parts of NKRI Nusantara Indonesia, placing the country under the threat of being foreign owned; the current proposal, by Finance Minister, Sri Mulyani, for the illegal sale of Bali due to the inability to repay the escalating country debt; SWISSINDO WORLD TRUST INTERNATIONAL ORBIT, known as the UN Swissindo has the ONLY Solution in preventing further cascading errors of the country leaders, since the assassination of President John F Kennedy, November 22, 1963), following his signing of the Green Hilton Agreement with President Soekarno on November 14, 1963 (which he was to announce to Americans on Nov 22) and Soekarno lost his power, as the President of one of the most resourceful rich countries, soon after.
