### **HISTORIC GENERAL MANAGEMENT MERGER BETWEEN UN SWISSINDO (UNS) AND DIRUNA (DRA), THE FIRST CRYPTO-TOKEN CURRENCY BACKED BY GOLD CONCLUDED WITH A WRIT OF PAYMENT FOR PHASE 1 DISTRIBUTION**

**CIREBON, JAVA, Indonesia, 8<sup>th</sup> July 2019** – On 11 June 2019, a writ-of-payment notification (Berita Acara Surat Perintah Pembayaran) regarding the Historic General Management Merger between Swissindo World Trust International Orbit (UN Swissindo) and DIRUNA Cryptocurrency was sent from the WPM of Finance & Banking, H.M. The Token Program UNS-DRA Usage application is guaranteed by Collateral Exhibits AB. UNS-DRA Program (Diruna/Dirham Dinar) is the currency of the World Central Bank, World Single Currency, backed by gold.
