### **OJK & INVESTMENT ALERT TASK FORCE (SATGAS WASPADA INVESTASI) DEPRIVE INDONESIAN PEOPLE OF HUMAN RIGHTS!**

**CIREBON, JAVA, Indonesia, August 29, 2017** - In a meeting with UN Swissindo (UNS) on August 23, 2017, OJK (an appointed Indonesian government agency that regulates and supervises the financial services sector) and the Investigation Task Force attempted to deprive the People of their Human Rights. In a meeting with an agenda for '**Discussion on clarity of the legality and activities of UN Swissindo**', the motives originally shared in the invitation were abruptly changed to intervention and coercion, which was held in OJK Executive Office located at Gedung Soemitro Djohadikusumo, No. 2-4, level 16, Jalan Lapangan Banteng Timur, Jakarta. The OJK, which only has authority in Indonesia, have been using the Media to defame and slander a Non Profit International Humanitarian Organization in an effort to impede the UNS' Mission to free all world citizens from the corrupt debt slavery system. M1 Vouchers continue to spread across 5 continents; Asia, Africa, Europe, America and Australia to support Guaranteed Basic Income for Life starting in Indonesia, until it is fully realized.

In truth, UNS has nothing to do with the OJK, whose tasks relate to services in finance, investment and profit matters. UNS, as LTTN and LTTB means it is higher than any Nation and Country Institution. UNS is not under its authority; and as a Non Profit Humanitarian Organization covering 5 continents, is not an investment or financial institution and does not collect or receive funds or profit from anywhere. UNS' only Mandate is to distribute the inherent wealth of/ from the People to the People and eventually the world. This is NOT Government property or money! It is designated for the welfare of all Earth's humanity. That is UN Swissindo's Mandate, since its establishment in 1887!

When OJK was pushed to the forefront to impede the UNS mission (by whomever gave the order) Royal K.681, King of Kings, H.M. MR.A1.Sino.AS.S "2" .IR.Soegihartonegoro H.W.ST.M1, (M1), Top President of UNS gladly accepted their invitation to this meeting on August 23, 2017 in hopes of reaching a solution to speed up the very current M1 Voucher process that is awaited by all Indonesian People, including members of the TNI, POLRI, Civil Servants, as well as probably members of OJK and Investment Alert Task Force.

Unthinkable injustice occurred throughout that meeting between OJK, the Investigation Alert Task Force and UNS. Included in the OJK party were Bareskrim Polri (Police RI) dan Bank Indonesia. HNP & Partners, the Advocates, who have been given power of Attorney by the Indonesian People, and M1 Vouchers recipients, were also formally invited by the same party yet were refused entry to the meeting by OJK, who locked the doors. That means the Public RIGHTS were clearly neglected!

Following this action, the meeting Agenda for 'Discussion on clarity of the legality and activities of UN Swissindo' was abruptly switched into one of threatening aggression, intervention and coercion, which resulted in the issuance of a pre-scribed document from OJK and Investment Alert Task Force, which had not been disclosed in the invitation, designed to force UN Swissindo to immediately cease all activities of its Humanitarian Mission including the DBLC and M1 Voucher under the direct threat of immediate arrest of all concerned-- including volunteers, who support the Mission, if Honourable M1 did not sign their document.

The document stated, "DBLC is the RIGHT to eliminate all debts of individuals, corporations and countries, MUST STOP immediately! M1 Voucher is the RIGHT of Guaranteed Basic Income, US \$ 1,200 / RP. 15.6 million per month, for life, MUST STOP immediately!"

A King's primary duty is to protect the people of whom he serves. UN Swissindo's King of Kings, Royal K.681, H.M. MR. A1.Sino.AS.S"2".IR. Soegihartotononegoro H.W.ST.M1 (M1) has acted under duress, in order to uphold his primary duty of protecting the people and avoid threats of arrest. The very fact that he, his UN SWISSINDO Officers and delegates alike, were threatened with arrest unless he signed this document means ( in law) that it was signed under duress and has no legal or lawful standing in any court and in any land and is **rescinded, null and void ab initio**.

Mr. Wimboh and Mr. Tobing, of OJK do not have the Authority to change HUMAN RIGHTS nor the United Nations Founder and President Soekarno's Mandate, nor the Will of God!

The UNS Mission is not just the RIGHT of the Indonesian People, it is the RIGHT of all of the People around the World.

**UNITED NATIONS (UNIVERSAL) DECLARATION OF HUMAN RIGHTS 1948, Article 25:**

*(1) Everyone has the right to a standard of living adequate for the health and well-being of himself and of his family, including food, clothing, housing and medical care and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond their control.*

All officers of RI Government have a legal and moral duty to now assist M1, UN SWISSINDO and the Indonesian people in securing their God-given mandated abundance through Payments 1-11.
